**NOTICE OF ACTUAL JAIL COSTS OWED BY DEFENDANT AND  
REQUEST FOR COURT-ORDERED PAYMENT  
PURSUANT TO 22 O.S. §979a (as amended)**

The Sheriff of Harper County, Oklahoma hereby gives notice to Defendant the following account of actual jail costs incurred by Defendant, while Defendant has been in the custody of the Sheriff.

The Sheriff requests the District Court to order Defendant to pay and reimburse the Sheriff pursuant to 22 O.S. §979a (as amended) and as follows:

1. Defendant's Book-in Date: 11-21-16
2. Defendant's Book-out Date (or date of judgment and Sentence for felony case): 11-23-16
3. Defendant's Total days in jail: 3 days
4. Sheriff's per diem jail fee of incarceration for Defendant: \$ 35<sup>00</sup>
