

## TRANSCRIPTION

STATEMENT OF: Rex A. Frederickson, d.o.b. 12-01-62

I met [REDACTED] 4 or 5 weeks ago. She found out that I lived near and she began coming to my house before and after work. To get in order of occurrence I invited her to walk my dogs for promotional effort having painted me dog blue to attract peoples attention. This is the first instance of physical contact. We exchanged back rubs.

As time progressed we became less aware of boundaries.

On or about 5/28/01 she came to my house. We gathered in my bedroom to talk and watch TV. I had discussed working for Sunbird as a salesperson prior to this and layed on the bed with notebook to explain what may be asked of salespeople and began cuddling. During this time she placed her hand in my pants and began rubbing me. She did this till I came. I didn't force her to do this. She layed across me face up and I was face up during this time. She left shortly after this and came back that evening. On or about 5/30/01 she came over again and after helping or following me through my chores. We went to my bedroom to talk about her quitting her job.

She backed me to the bed and with no room gave me no choice but to pull myself up and lay down. She layed on top of me to continue to cuddle I spoke of dangers we could have at my expense. We continued to cuddle and (unreadable) each other clothed as we would be for swimming. her top was off and her bra. She gave me room between us so I my kiss her breasts and shoulders as she was on top.

We continued to cuddle with clothes mostly off and rolled back and forth to try turns on top as we (unreadable) each other. She allowed me to kiss her about the neck and down her stomach till I was having oral sex with her. We changed back and forth getting more carried away. We (unreadable) dry fucked until with her on top and she relocated herself 2 times maybe 3 and tried to push her self on me. I pulled us over with me on top and placed myself above her opening to slide as we were snuggling lifted herself to alignment parts After a silent argument of placement (scratched out sentence) As we placed ourselves in different positions and as close as I was to intercourse. In the excitement I came.

During the cuddling we mutually masterbated each other. She stroked my penis with her hand. I masterbated her with 2 fingers inside and outside of her vagina as she moved to signify witch she wanted.

At no time was force used or displayed by either of us. At no point did I threaten or make aggressive movements or verbal abuse of her. All that had happened was in mutual gratification.

I met Rex Warfield on 4-23-01 when I met him randomly at Steamers Hot Dogs, [REDACTED]. He introduced himself to me by saying "Hi...would you marry me"? Over the next couple of weeks we talked at Steamers. He told me about his business, "Sunbird Entertainment" and invited me over to his house to learn about his business website. On 4-26-01 I told him that it was my 16th birthday.

On Monday 05-28-01 I went to his house, 428 Dalhart, for the first time. I was there from about 1:30 p.m. to 4:00 p.m. During that we talked about his business and himself. He told me his name was Rex Warfield and that he was 40 years old.

On Tuesday 05-29-01 I went to his house again. There were some others there so we went into his room to talk about his business without being distracted by their noise. At some point during that time he also asked me if I was a virgin. I was still a virgin but did not want him to know because it was none of his business so I did not answer. After talking for about 20-30 minutes he started playing with my pants belt buckle and undid my pants button. I asked him what he was doing and pushed him away. I left the house right away after this.

On Wednesday 05-30-01 I went to his house again at about 2:00 p.m. . There were other people there and we talked until about 5:30. He and I then went into his room to talk alone. After about 20 minutes he started kissing me on the mouth and neck and touching my breasts and buttocks. I did not want him to do this and became very scared and "blocked it out". I wanted to say "no", but was afraid that if I said "no" it would happen anyway and be worse. I remember having unprotected vaginal intercourse one time. After the sex he looked into my genital area and said, "oh good, I didn't tear anything" and "Well, at least now my rage is over". I got dressed and left his house right away.

I was really upset and did not tell anybody about it until my Counselor, [REDACTED], asked me what was bothering me.
